## COMMISSION MEETING AGENDA

- 1. <u>Recording Mortgage Servicers</u> Consideration of a Draft Tentative Report revised to move administration of mortgage servicer recording to the counties.
- 2. <u>Title 9 Child Abuse and Neglect</u> Consideration of a Draft Tentative Report revising and consolidating the law regarding child abuse and neglect and a Memorandum including a petition raising an issue concerning the definition of child abuse.
- 3. <u>Tuition Aid Grants</u> Consideration of a proposed project recommending a modification of *N.J.S.* 18A:71B-2 (Student eligibility) as a result of the Court's determination in *A.Z. ex rel. B.Z. v. Higher Educ. Student Assistance Authority*, 427 N.J.Super. 389 (App. Div. 2012).
- 4. <u>Bias Intimidation Statute (*N.J.S.* 2C:16-1)</u> Consideration of a proposed project recommending a modification of *N.J.S.* 2C:16-1, subsection a.(3), as a result of the Court's determination in *State v. Pomianek*, 430 N.J. Super. 339 (App. Div. 2013).
- 5. <u>Revised Uniform Law on Notarial Acts</u> Consideration of a uniform law recommending enactment of minimum standards for all notarial acts, governing the recognition of interstate and intercontinental notarizations, and applicable to notarization of tangible and electronic records.
- 6. <u>Uniform Asset-Freezing Orders Act</u> Consideration of a uniform law designed to create a uniform process for the issuance of asset freezing orders.
- 7. <u>Uniform Deployed Parents Custody and Visitation Act</u> Consideration of memorandum regarding the uniform act.
- 8. <u>Traffic on Marked Lines</u> Consideration of a Draft Final Report proposing a revision to *N.J.S.* 39:4-88 subsection b.
