1. Child Endangerment – Consideration of a Draft Final Report proposing clarification of the standard of harm required to convict a defendant pursuant to N.J.S. 2C:24-4(a) in response to the New Jersey Supreme Court decision in *State v. Fuqua*, 234 N.J. 583 (2018). [Report](#)

2. Confinement - Consideration of a Draft Final Report proposing changes to clarify the meaning of "confinement" in the New Jersey's persistent offender statute, N.J.S. 2C:44-3(a) as discussed in *State v. Clarity*, 454 N.J. Super. 603 (App. Div. 2018). [Report](#)
