The New Jersey Law Revision Commission is continuing to comply with changes to New Jersey's Senator Byron M. Baer Open Public Meetings Act, Executive Orders issued by the Governor of the State of New Jersey, and recommendations issued by the Center for Disease Control and Prevention (CDC) regarding "social distancing." 1. County Committee – Consideration of a Revised Draft Final Report recommending the conclusion of work on this project in recognition of the fact that modification of the law in this area requires policy determinations best suited to the Legislature. [Report](#)

2. Workhouse - Consideration of a Draft Final Report proposing statutory modifications to eliminate references to the term "workhouse" from the New Jersey statutes where appropriate. [Report](#)
