**1. Interpretation of the Vote by Mail Law** – Consideration of a Draft Final Report recommending: (1) modification of N.J.S. 19:63-26 and N.J.S. 19:29-1 to reflect the holding of *In re the Election for Atlantic County Freeholder District 3 2020 General Election*; and (2) modification of the Campaign Contributions and Expenditures Reporting Act and N.J.S. 19:29-2, to clarify the scope of the Election Law Enforcement Commission’s jurisdiction over violations of the Act. Municipalities Right of Action to Sue for Cable Fees – N.J.S. 48:5A-1, et seq.** – Consideration of a Memorandum proposing a project to consider whether the Cable Television Act would benefit from modification to clarify whether the Legislature intended to provide a private right of action for municipalities to enforce fee provisions pursuant to N.J.S. 48:5A-1, et seq., as discussed in *Borough of Longport v.
