1. **Kidnapping** – Consideration of a Revised Draft Tentative Report proposing changes to clarify the “unharmful release” provision of New Jersey’s kidnapping statute, N.J.S. 2C:13-1(c)(1) as discussed in *State v. Sherman*, 367 N.J. Super. 324 (App Div. 2004) and *State v. Nunez-Mosquea*, 2017 WL 3623378 (App. Div. Aug. 24, 2017). [Report](#)
