Interpretation of the Vote by Mail Law in N.J.S. 19:63-26 – Consideration of a Revised Draft Tentative Report proposing modifications to N.J.S. 19:63-26, N.J.S. 19:29-1, N.J.S. 19:29-2, and the Reporting Act to reflect the holding of *In re the Election for Atl. Cnty. Freeholder Dist. 3 2020 Gen. Election*, 468 N.J. Super. 341 (App. Div. 2021), and clarify ELEC’s jurisdiction over violations of the Reporting Act. [Report](#)

2. Juvenile Justice – State Home for Boys and Girls as used in N.J.S. 30:4-85 – Consideration of a Draft Tentative Report proposing the removal of anachronistic references to the State Home for Boys and the State Home for Girls. [Report](#)
